
Lorena Loaiza

FAREWELL TO OUR SWEDISH SOCIAL WORKERS

During a three week training program in July, Ulrika Elofsson, Lisa Ekman, and Julia Jonaszon became familiar with the United States social work system. The delegates work within a variety of social work fields including therapy, teaching, domestic violence, and family therapy. While in Columbus, the group met with professionals from many organizations including The YWCA, LifeCare Alliance, HandsOn Central Ohio, and The OSU College of Social Work. During a two-day



visit to OSU, the delegates learned about the history of social *Josefa Trugilo (a social worker from Spain)*, work in the United States, social work licensure, homelessness, *Julia, Kathy (CIP staff), Lisa, and Ulrika* and family services. INDIA YOUTH ADVOCACY PROGRAM

Three International Professionals in Residence (IPR) will be arriving in September as part of the India Youth Advocacy Program (IYAP). This program will take place from September 8th to September 30th. Their program will provide advanced training in the area of children with disabilities, with special focus on the hearing impaired. About the participants:

Anjanaa Chattopadhyay is originally from India and is a freelance Bengali interpreter, translator, proofreader, and copyrighter. She has been volunteering as a counselor for cancer patients for the past eight years and has also worked with underprivileged youth. Anjanaa is eager to work with hearing impaired and disabled individuals and learn how to improve the systems present in India.

Resham Mahtaney is originally from Singapore but now resides in Mumbai, India. She has worked with an organization called Asha Daan where she helps handicapped children and is now working with the NGO, Cancer Patients Aid Association. Resham hopes to learn how to empower youth with disabilities.

Natty Lopes is originally from India and has been working as a social worker for quite some time. She is very interested in working with underprivileged and disabled youth and learning how to foster important skills in them for thriving in this day and age. Natty is a member of CIF (Council of International Fellowship) India, and we look forward to future collaborations with CIF India.

WOULD YOU LIKE TO HOST?

Hosting an international guest is a great way to learn about another culture and to make a life-long friend. Whether you are a single person, a working couple, a family, or a retiree, you can serve as a host. Hosts do not need to speak their guest's native language because most speak English, and many welcome the opportunity to practice their English skills. Not only do host families help an individual learn about American culture, but they also gain first-hand experience with guests from a different country. Hosts can earn a tax deduction, are invited to attend our events free-of-charge, and may be eligible to receive a monetary stipend. As a host, we ask that you provide the following services to your guests: breakfast and dinner, a private bedroom (preferably a private bathroom as well), transportation as needed (we can help coordinate this).

We are looking for hosts for the following IPR's:

Malle Luik is a Clinical Psychologist from Estonia. She will be in Columbus from September to December, and will need a host starting in October. Malle works as a music therapist for youth with disabilities, and as a counselor and psychologist. She has also taught music, piano, and psychology. While in Columbus, Malle will train as a music therapist at the Central Community House in Bexley.



Kadie Alukula is also from Estonia. Her training plan in Columbus will extend from October of 2014 to April of 2015. Kadie works in Law and Social Sciences in the Ministry of Social Justice in Estonia. She is passionate about human rights protection in prisons and prison management. She will be training at the Metropolitan Community Services T.O.U.C.H. Program where she will gain experience in rehabilitation and helping at risk populations.



Ten Social Workers from China will train in Columbus from October 19th to November 8th.

Their program will provide training in the fields of Social Work, Psychology, and Community Development. Please consider hosting one of the Social Workers arriving as part of this program. Please consider supporting the Buckeye Health Clinic in South Sudan. Set up by Jok and Bol, two of the Lost Boys of Sudan who escaped the war and came to Ohio, the clinic has been providing medical attention, food, and supplies to people in need. Although South Sudan gained its independence three years ago, the country continues to be affected by ethnic warfare. Currently 40% of the population is in danger of famine. Since January 2014, the Buckeye Health Clinic has been able to help 216 families, totaling 1,200 individuals.
